Dallas Baptist University named Dallas attorney Vester Hughes as the recipient of the 2012 Russell H. Perry Free Enterprise Award during the annual dinner held on November 19, at the Hilton Anatole Hotel in Dallas. Dr. William "Bill" M. Pinson, Jr., executive director emeritus of the Baptist General Convention of Texas, served as the honorary chair for the dinner, and Dr. James "Jim" Denison, founder and president of the Denison Forum on Truth and Culture, served as the chair and dinner speaker.

Mr. Ron Harris, senior vice president for Strategic Partnerships for National Religious Broadcasters and former DBU assistant professor of communications, was the evening's emcee.

Established in 1988, the 25th annual gala event strives to recognize and honor Texas leaders who use their God-given talents and abilities to make the most of opportunities created for them by the free enterprise system. The event is named in memory of

Dallas leader and philanthropist Mr. Russell H. Perry, whose life of service to Dallas impacted the lives of many. Mrs. Russell H. (Phoebe) Perry continues to remain a friend of Dallas Baptist University. She and her late husband began their support of DBU in the 1960s.

Since its inception, the dinner has raised more than \$4 million in scholarship funds for over 1,800 students. As emcee, Harris began the program by thanking those in attendance for their support of DBU, specifically on behalf of the students

who are directly impacted by the scholarship funds raised through this event.

Mr. Brent Christopher, president and CEO of Communities Foundation of Texas, led the Pledge of Allegiance. It was followed by the DBU Grand Chorus (pictured below) leading the National Anthem with DBU student Mr. Aaron Jones as the featured soloist. The Grand Chorus was under the direction of Dr. Stephen Holcomb, director of choral activities and professor of music. Mr. Jeff Smith, president-elect of the Baptist Foundation of Texas, then offered the invocation. Dinner music was provided by Mrs. Sue Mitz, longtime DBU professor of music.

Dr. Gary Cook, DBU president, shared a word of gratitude for those in attendance. He paid special tribute to Mr. John Clem, director of development, for his involvement in planning all 25 Russell Perry Dinners for the University. Dr. Cook then honored Mr. Hughes, noting

The DBU Grand Chorus performed a patriotic medley entitled "Freedom!" conducted by Dr. Holcomb.

A long-time friend of Mr. Hughes, Dr. Denison shared personal stories of the faith and influence that Mr. Hughes has had upon countless individuals. Dr. Denison served as Mr. Hughes' pastor at Park Cities Baptist Church for over ten years, and the two developed a strong friendship.

Dr. Denison shared, "I have been preaching and speaking in public for over 36 years, and I have never been as honored as I am tonight. To be able to speak to you about a man I love, to a university I love, is an honor I will never forget."

Dr. Denison explained to those gathered the valuable lessons that he has learned through his friendship with Mr. Hughes and how Mr. Hughes has lived out the truth that "what matters

most in life is not what we possess, not the accolades that are given, but the people that we serve."

Afterwards, Mr. Steve Blow, a columnist for *The Dallas Morning News*, introduced a special video presentation about Mr. Hughes from friends and colleagues who offered their praise and congratulations to Hughes for being honored. *The Dallas Morning News* continues to serve as a sponsoring partner of the dinner.

Following the video, Dr. Pinson took the stage to present the Russell H. Perry Free Enterprise Award to Mr. Hughes and reflected on their friendship through the years.

During his introduction, Dr. Pinson noted the three things that have made Mr. Hughes such a remarkable individ-

ual – family, faith, and friends. "Thank you for family, and letting us be part of that family," Dr. Pinson expressed. "Thank you for faith; it's contagious. And, thank you for friends; you have a host of them all over the world."

In closing, Dr. Pinson shared Philippians 1:3, "I thank my God upon every remembrance of you."

Mr. Vester Hughes has been a partner in the Dallas law firm Hughes & Luce, which merged with K&L Gates in 2008, since 1973. Mr. Hughes has been a great supporter of Dallas Baptist University, serving as a trustee from 1968 to 1977. He has also been a faithful member of Park Cities Baptist Church for many years.

School, Mr. Hughes was admitted to the Texas Bar in 1952. He has been a member of the academic honor fraternity Phi Beta Kappa since 1949 and has been practicing law in Dallas since 1955.

A well-known and highly respected tax attorney, Mr. Hughes has argued before the United States Supreme Court and has served as lead counsel in two additional cases before the High Court. He continues to participate in litigation at all levels of trial and appellate courts, including arguing cases in U. S. Courts of Appeals, U. S. Claims Court, Texas Supreme Court and other courts of administrative agencies as well as presenting cases to Federal District courts and the United States Tax Court.

On several occasions he has successfully lobbied Congress on behalf of clients to amend the federal tax laws, and he often is called on by staff members of the Treasury Department and the Congressional tax-writing committees for his views and opinions concerning current and proposed tax policies.

Mr. Hughes has faithfully been a part of the Dallas Baptist University family since its move from Decatur in the 1960s, serving as a trustee, benefactor, and friend. His continuing support has left a lasting impact on the University.

Mr. Hughes has served on numerous advisory groups and committees in various associations within the legal profession, including the American Law Institute, ABA Section of Taxation, ABA Section of Real Property and Probate, and the Texas State Bar, as well as others. He has also appeared before the United States Supreme Court on tax issues and before various other high courts in Texas and Arkansas.

Mr. Hughes maintains a long-standing relationship with many community service organizations, including Communities Foundation of Texas, Inc., Texas Scottish Rite Hospital for Children, and Goodwill Industries.
